Required E.M.D. in shape of NSC , KV P , BD, Post office saving pass book duly pledged in favour of the EO-I , Directorate of AH & VS , Orissa , Cuttack along with up to date attested copy of VAT clearance certificate , Income Tax clearance certificate vide PAN no. must be enclosed with the Tender falling which the Tender is liable to be rejected. The contractors are also requested to submit the no relation certificate failing which the Tender will not be considered for acceptance.

The Tender Paper will be issued on application to the Asst. Engineer(C) in the Directorate on payment of cost of Tender Paper which is non refundable on the working days in the office hour only and original valid registration certificate along with Original VAT clearance certificate, and IT clearance certificate are to be produced before the above authority falling which no paper will be issued.
