Tender form are obtainable from the office of the under signed on payment of Rs. 10000/- (rupees ten thousand only) + VAT @ 4% as per the codal provisions of the State of Orissa. The same can also be obtained by post on payment of Rs 10100/- (Rupees ten thousand one hundred only) + VAT @ 4% in shape of bank draft issued in favour of "Establishment Officer, Directorate of Animal Husbandry and Veterinary Services ,Orissa, Cuttack payable at SBI, Link Road Branch, Cuttack. The money receipt in respect of cost of tender paper should be enclosed in original along with the tender documents. All prospective tenderers (Manufacturers as above only) are required to quote the price for the schedule items along with the requisite EMD of Rs. 2, 00,000 /- (Rupees two lakh) only in shape of Bank Draft to be drawn in favour of Director of AH & VS payable at SBI Cuttack, Link Road Branch, Cuttack.

The tenderer are required to furnish VAT clearance certificate in form - 612 if they have branches inside the State of Orissa or furnish an undertaking that they have no business in State of Orissa and have no liability under OVAT act as per Finance Department, circular no. :3202 (230) CTA12/2008. After finalization of tender the purchase shall be regulated as per the FD circular no.:48317 (230) F dt 23.11.2010.The validity of expiry date of the procured item shall be nine months minimum from the date of supply .

In the event of any of the above mentioned dates being declared as a holiday / closed day for the purchasing organization, the tender offers shall be received/opened on the next working day at the appointed time. After award of the contract for supply or in the event of failure to supply the requisite vaccine as per the supply schedule notified as above the EMD of the awardee shall be forfeited and further lawful actions shall be taken including closure of the business dealings with the Government organization. The EMD of the unsuccessful / tenderer shall be refunded within 7 days from the date of completion of the supply schedule. Successful bidder shall have to deposit security deposit @ 2 % of the purchase value within 7 days of receipt of purchase order. The Director of AH & VS reserves the right to modify / alter / cancel at any time the tender without assigning any reason thereof. Any dispute arising out of the contract is subject to Cuttack jurisdiction. The bid/tender /offer document once filed shall remain valid for a minimum period of 90 days. The rate shall not exceed to Govt. of India approved rate under any circumstances. The rate once approved shall remain firm upto 30th November, 2011 subject to force majeure clause.
