

TENDER CALL NOTICE No.3(Pur)/2010-11 dt. 30.6.10


Sealed tenders for supply of instrument and equipments for the year 2010-11 are invited from registered dealers/ manufacturers / authorized distributors/ authorized agencies having up-to-date VAT & IT clearance certificate, up-to-date drug license in conformity with detailed tender documents. The Tender documents with required details can be obtained from the Office of the Director of Animal Husbandry & Veterinary Services, Orissa, Mangalabag, Cuttack-1 on payment of Rs. 10,000/- (Rupees Ten thousand) only + VAT 4% in shape of cash (Non refundable). The same can be obtained by post on payment of Rs.10,050/- (Rupees ten thousand and fifty) only + VAT 4% in shape of Bank Draft issued in favour of "Establishment Officer", Directorate of Animal Husbandry & Veterinary Services, Orissa, Cuttack payable at SBI Link Road Branch, Cuttack at least one week prior to last date, accompanied by the request in plain paper alongwith a self-addressed envelope of 9" x 12" size with postage stamp of Rs. 50/- affixed on it.

2. The cost of Tender Paper with documents is compulsory and non-refundable and the receipt so obtained against payment should be enclosed in original alongwith tender papers.
3. Guarantee / Warranty period for the instruments and equipments must be mentioned in the tender paper.

The Tender paper complete in all respect alongwith the original Money Receipt towards cost of Tender Paper and EMD of Rs.1,00,000/- (Rupees one lakh) only should be submitted in the office of the undersigned as per the following time schedule. The Tender Paper received after due date and time will not be entertained. The Department will not be responsible in any way for delay in receipt of Tender Papers sent by post.
